### Notice in relation to the CitiFirst Australian Index MINIs (Cboe)

8 November 2023

Citigroup Global Markets Australia Pty Limited (ABN 64 003 114 832 and AFSL 240992) (**Citi**) issued the product disclosure statements (each a **PDS**) in relation to CitiFirst Australian Index MINIs quoted on Cboe specified in Annexure A to this notice (each a **CitiFirst Australian Index MINI**).

In accordance with ASIC Class Order 2016/1055, Citi updates:

- (a) section 2.4 ('What Happens If An Issuer Call Occurs?') of the PDS, by inserting the blue underlined text as follows:

By giving Holders at least one calendar month's notice, Citi may, acting commercially reasonably, terminate a Series of CitiFirst Index MINIs (in whole but not in part).
- (b) clause 3.1c)iv of the terms of issue within section 9 of the PDS, by deleting the red struck through text and inserting the blue underlined text as follows:

the CitiFirst Index MINI has not been terminated or suspended from trading for any other reason (as determined by Citi ~~in its absolute discretion~~ acting reasonably).
- (c) the definition of 'Settlement Date' in section 10 of the PDS, by deleting the red struck through text and inserting the blue underlined text in subclause c) as follows:

such other date as determined by Citi, acting reasonably, ~~at its absolute discretion~~ and notified to the Holder.

The changes take effect at 5pm (Sydney time) on 8 November 2023.

Holders should always consider the PDS in its entirety when making any decision regarding their investment in CitiFirst Australian Index MINIs. The PDS can be obtained at [www.citifirst.com.au](http://www.citifirst.com.au).

Capitalised terms not defined in this notice have the same meaning given to them in the PDS.
