Notice in relation to the CitiFirst International Index and FX MINIs (ASX)

8 November 2023

Citigroup Global Markets Australia Pty Limited (ABN 64 003 114 832 and AFSL 240992) (Citi) issued the product disclosure statements (each a **PDS**) in relation to CitiFirst International Index and FX MINIs quoted on the ASX specified in Annexure A to this notice (each a **CitiFirst International Index and FX MINI**).

In accordance with ASIC Class Order 2016/1055, Citi updates:

- (a) section 2.4 ('What Happens If An Issuer Call Occurs?') of the PDS, by inserting the blue underlined text as follows:

By giving Holders at least one calendar months' notice, Citi may acting commercially reasonably, terminate a Series of CitiFirst MINIs (in whole but not in part).
- (b) clause 3.1c)iv of the terms of issue within section 9 of the PDS, by deleting the red struck through text and inserting the blue underlined text in substitution as follows:

the CitiFirst MINI has not been terminated or suspended from trading for any other reason (as determined by Citi ~~in its absolute discretion~~ acting reasonably).
- (c) clause 3.9 of the terms of issue within section 9 of the PDS, by deleting the red struck through text and inserting the blue underlined text in substitution as follows:

In the event that the Underlying Level is calculated but not published by the Level Source, the Termination Date shall be postponed in accordance with clause 2.3, and the Final Reference Level shall be calculated by reference to the level of the Underlying as obtained by Citi from such publicly available sources it considers appropriate, ~~in its absolute discretion~~ acting reasonably.
- (d) clause 3.10 of the terms of issue in section 9 of the PDS, by deleting the red struck through text and inserting the blue underlined text in substitution as follows:

In the event that the Underlying Level is not calculated by the Level Source but is calculated and publicly announced by another person or Entity (the Third Party), the Final Reference Level shall be calculated by reference to the Underlying Level so calculated and announced by the Third Party, provided such Third Party is approved by Citi ~~in its absolute discretion~~, acting reasonably.
- (e) the definition of 'Settlement Date' in section 10 of the PDS, by deleting the red struck through text and inserting the blue underlined text in substitution in subclause c) as follows:

such other date as determined by Citi, acting reasonably, ~~at its absolute discretion~~ and notified to the Holder.

The changes take effect at 5pm (Sydney time) on 8 November 2023.

Holders should always consider the PDS in its entirety when making any decision regarding their investment in CitiFirst International Index and FX MINIs. The PDS can be obtained at www.citifirst.com.au.
