Overnight Headlines:

- Oil futures posted their largest gain in more than a year last week. And the
 frenzy was even bigger in the options market. As traders fretted over the risk of
 a major price spike, the call skew on second-month West Texas Intermediate
 futures jumped to the highest since March 2022 when Russia's invasion of
 Ukraine sparked concerns that millions of barrels a day of oil from one of the
 world's top producers would suddenly disappear from the market. (BBG)
- As Chinese stocks in Hong Kong head for their best two-week rally since 2007, questions are arising over just how far this rebound can go. The Hang Seng China Enterprises Index has gained 35% since last month's low, with a bulk of the gains coming after Beijing's bumper stimulus announcement on Sept. 24. Some stocks have seen astronomical gains as share prices more than doubled in a matter of days. (BBG)
- Florida prepared on Sunday for its largest evacuation since 2017 as Hurricane
 Milton intensified in the Gulf of Mexico on its path toward the U.S. state's
 western coast, coming on the heels of the devastating Hurricane Helene.(RT)
